<b>Term of Delivery</b>	Term 1
<b>Mode of Delivery</b>	For 2022-23 this module will be delivered by predominantly face-to-face teaching modes.  Where specific teaching methods (lectures, seminars, discussion groups) are noted in this module specification these will be delivered by predominantly face-to-face sessions. There will be a combination of live and interactive activities (synchronous learning) as well as recorded or self-directed study (asynchronous learning), plus face-to-face laboratory classes.

<b>Language of Study</b>	English
<b>Pre-Requisites</b>	As for the MSc TMIH, the module is open to doctors who hold a medical qualification from a recognised medical school in any country and are registered to practice medicine by their national regulatory authority. Preference will normally be given to doctors who have several years' experience in clinical practice.

<b>Target Audience</b>	This module is intended specifically for students on the MSc Tropical Medicine and International Health.
<b>Module Description</b>	The module comprises the learning in tropical medicine, parasitology and public health delivered via the DTMH seminars, practicals and live sessions.



<b>Duration</b>	Students study full time for 12 weeks (three months), comprising 600 notional learning hours.

## Module Aim and Intended Learning Outcomes

<b>Overall aim of the module</b>
<p>The overall module aim is to:</p> <ul style="list-style-type: none"> <li>provide medical doctors with the skills required to understand, diagnose, treat and prevent diseases that are especially prevalent in tropical and low resource countries.</li> </ul>

<b>Module Intended Learning Outcomes</b>
<p>Upon successful completion of the module a student will be able to:</p> <ol style="list-style-type: none"> <li>Compare and contrast the management of communicable and non-communicable diseases in different contexts;</li> <li>Critically evaluate the evidence for public health interventions in resource-limited settings;</li> <li>Prepare and examine biological specimens for identification of common parasitic and bacterial pathogens and associated vectors</li> <li>Demonstrate understanding of the biology and the life cycles of the major pathogens and of their vectors or intermediate hosts;</li> <li>Demonstrate understanding of the pathogenesis and pathology of the major tropical diseases;</li> <li>Appreciate the epidemiology of the major tropical infections;</li> <li>Interpret and apply basic epidemiological and statistical methods;</li> <li>Appreciate methods available for chemotherapy and control of tropical infectious diseases;</li> <li>Be able to communicate knowledge and understanding as appropriate to target audiences of different kinds.</li> </ol>

## Indicative Syllabus

<b>Session Content</b>
The module is expected to cover the following topics:



### Session Content

- Lectures cover the causative organisms, epidemiology, pathogenesis, clinical features, diagnosis, management and prevention and control of tropical diseases. Time is set aside after each lecture for discussion. Implications for travel medicine are discussed where appropriate.
- Other seminars focus on aspects of community public health. These include an introduction to epidemiological methods used in the study of communicable diseases, and lectures on water supply, sanitation and nutrition.
- Seminars are also held on maternal and child health, non-communicable disease, population and reproductive health and mental health.

## Teaching and Learning

Student contact time refers to the tutor-mediated time allocated to teaching, provision of guidance and feedback to students. This time includes activities that take place in face-to-face contexts such as lectures, seminars, demonstrations, tutorials, supervised laboratory workshops, practical classes, project supervision as well as where tutors are available for one-to-one discussions and interaction by email.

The division of notional learning hours listed above is indicative and is designed to inform students as to the relative split between interactive and self-directed study.



### **Teaching and Learning Strategy**

Much of the programme is devoted to seminars, in which a multi-disciplinary team of experts from within and outside the School covers a particular disease or group of diseases in depth.

The equivalent of one full day per week is devoted to parasitology teaching. Lectures link with hands-on practicals in which the laboratory diagnosis of all the major parasitic diseases is taught.

Clinical activities include problem-based teaching, small group discussions, case presentations, and participation in HTD Grand Rounds.

### **Assessment**

#### **Assessment Strategy**

The assessment for this module has been designed to measure student learning against the module intended learning outcomes (ILOs) as listed above. Formative assessment methods may be used to measure students' progress. The grade for summative assessment(s) only will go towards the overall award GPA.

The assessments for this module in Term 1 will be face to face.

The module will be assessed by three in-module assessment tasks (50%) and final unseen written assessments (50%) which will be conducted face to face in Week 0 of Term 2 in January 2023

The in-module assessment tasks will be of various types which may include individual tasks (such as evidence reviews, essays, preparing educational material, posters or presentations), structured tasks (for example an unseen written assessment or multiple-choice answer exam), collective tasks (such as groupwork) or combinations of the above.

The final unseen written assessments may include similar structured or practical tasks.

The nature and timing of the in-module assessments will be notified by the Module Organisers during Term 1.

The final unseen written assessments will be during the week before the start of Term 2 (Week 0). They will be face to face in 2023. Depending on LSHTM coronavirus policy, we do not plan to have online alternatives available.
