This module is available to students registered for the DL MSc and PGDip in Public Health. It is recommended for students studying MSc Public Health: General stream and the Environment and Health and Health Promotion streams. The module is also open to students on the DL PGDip/MSc Clinical Trials and Epidemiology programmes. Alternatively, it can also be taken as an individual module.
Module Description	The module discusses how linked global changes, known as globalisation, impact on social, economic, environmental and political spheres, and the impacts of these on health determinants and health.
Duration	Studies for distance learning modules begin in early October. At this time, module materials will be made available on Moodle and the module textbook will be made available once fees have been paid. Students may start their studies at any time from the beginning of October and work through the material until the start of the June assessments. However, students are encouraged to commence their studies in October and work steadily through the materials over the course of the academic year and must adhere to other assessment submission deadlines.

Module Aim and Intended Learning Outcomes

Overall aim of the module

This module aims to:

• improve students' ability to analyse the interactions between contemporary global changes, known as globalisation, and global health.

Module Intended Learning Outcomes

Upon successful completion of the module a student should be able to:

- 1. Describe and give examples of key concepts such as global change, globalisation, global health and governance, and the concepts of rapid spatial, temporal and cognitive changes with links to global health;
- 2. Describe and give examples of the various drivers and forms of global change (e.g. environmental, economic, spatial, technological and cognitive), and their relationship with globalisation processes;
- 3. Critically analyse empirical evidence of the links between global changes and health, and the methodological tools available to measure such links;
- 4. Describe examples of global health issues and assess how they influence human health using case studies on environmental change, communicable and non-communicable disease control, and multilateral trade agreements;
- 5. Critically analyse challenges to effective responses to global health problems using examples related to global health governance.

Indicative Syllabus

Session Content

The module is expected to cover the following topics:

- Conceptual frameworks for understanding different types of global change taking place, the key drivers of globalisation, and the main features of the shift from national to global health;
- Overviews of global change impacts on the social, economic, environmental and political spheres;
- Examples dealing with familiar public health issues from a global perspective (e.g. infectious and non-infectious disease, pharmaceuticals, tobacco control, alcohol, food, and human rights);
- Debates from policy areas and agendas outside the health sector impacting health at a global level (e.g. trade and trade organisations, security and human rights legislation, major industries of tobacco, alcohol, and pharmaceuticals, and environmental change);
- Review of global health governance structures and forms of global health policies, institutional reforms, and international law and other forms of cooperation.

Teaching and Learning Strategy

Learning is via directed self-study. A guide to studying the module is provided, together with access to a range of study resources, discussion forums and online webinar discussion sessions. The textbook that supports this module provides a detailed set of learning objectives at the start of each chapter, and also offers focused reading and various learning activities. Students are strongly encouraged to participate in the module-specific discussions and online webinar discussion sessions to obtain tutor support, and to make use of the LSHTM online library resources. Written feedback is provided on submitted assignments.

Student participation in online activities and discussion for a strengthens learning and reduces isolation in studies. Students are strongly encouraged to participate in the module-specific discussions and real-time tutorials available on Moodle to obtain tutor support, and to make use of LSHTM online library resources. Participation in Moodle discussions and activities is particularly important in this module due to the fast-changing scenarios created by globalisation. Students are expected to participate in Moodle activities at least once a term.

Assessment

This module is assessed via one summative assignment worth 30% of the student's mark and a summative time-limited assessment that is worth 70% of the student's mark.

Teaching for Disabilities and Learning Differences

The module-specific site on Moodle provides students with access to the majority of the module learning materials, including a study guide and online reading list (detailing both essential and recommended readings), and additional resources including supplementary exercises and optional lecture recordings. In some cases, module materials include a text-book that is made available to students in e-format. All materials posted up on Moodle areas, including computer-based sessions, have been made accessible where possible. The LSHTM Moodle has been made accessible to the widest possible audience, using a VLE that allows for up to 300% zoom, permits navigation via keyboard and use of speech recognition software, and that allows listening through a screen reader. All students have access to "SensusAccess" software which allows conversion of files into alternative formats.
